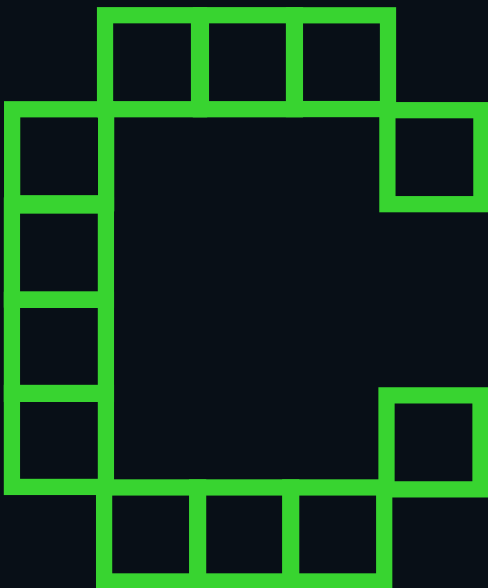


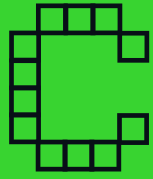

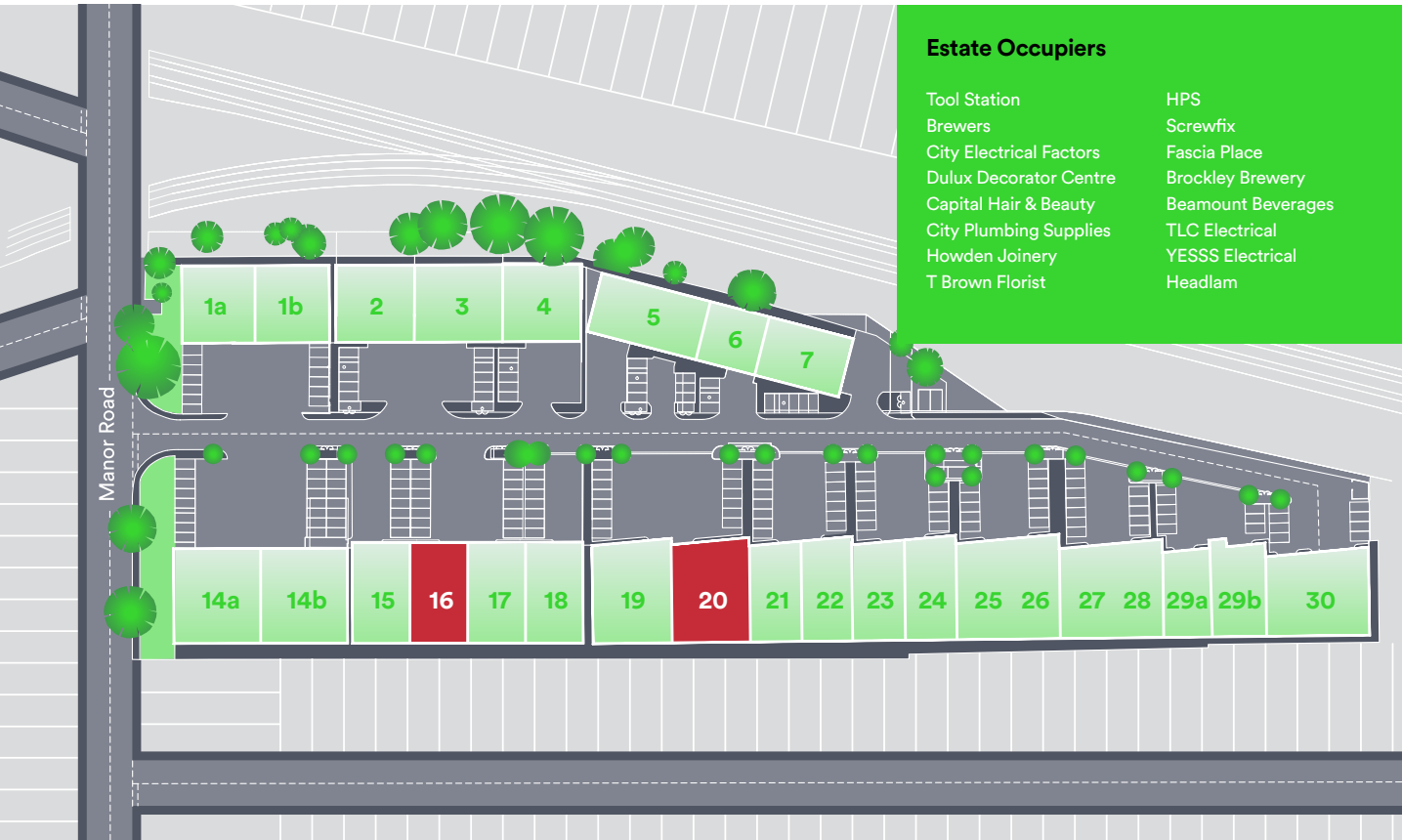

Site Plan

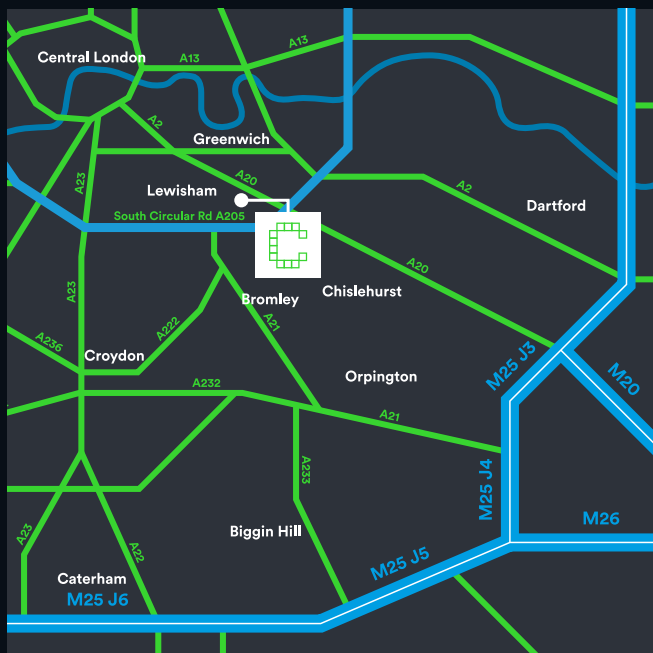
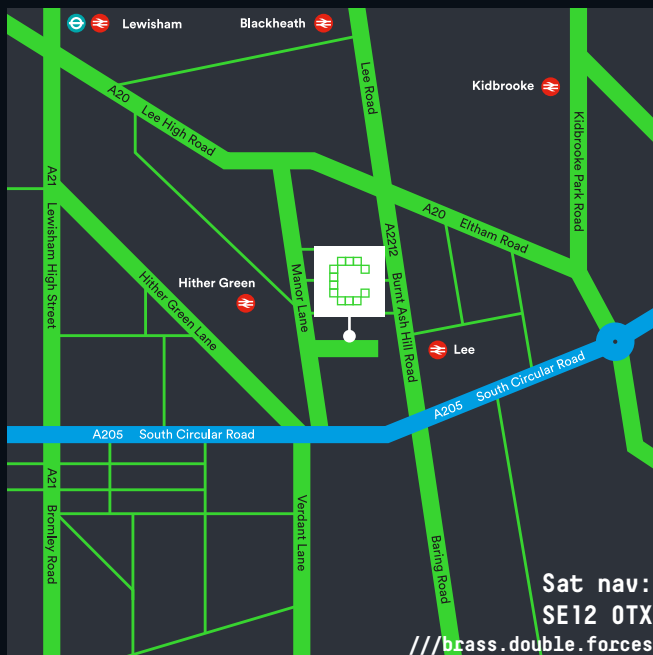
